Electricity Demand in August 2005 (Bulletin)

[Demand Overview (Total Across the 10 Power Companies)]

Total demand in August was down 1.8% to 80.6 billion kWh across the 10 companies.

Commercial and lighting demand posted declines of 0.9% and 3.9% respectively. The decline in lighting demand reflected the marked difference in cooling demand between last summer, which was the hottest on record, and this summer.
