(Reference) Large Industrial Demand

Total demand in November was up 4.5% to 70.0 billion kWh across the 10 companies.

Commercial and lighting demand posted increases of 3.2% and 5.1% respectively. The increase in lighting demand, which came despite generally higher November temperatures than last year, was due to a longer meter-reading period.
