Total demand in the first half of 2006 was up 1.9% to 446.8 billion kWh across the 10 companies.

Commercial and lighting demand posted increases of 1.4% and 1.8% respectively. The increase in lighting demand was due to increased demand for heating and cooling caused by lower temperatures in April and higher temperatures in August.
