Electricity Demand in the First Half of Fiscal 2008 (Bulletin)

Demand Overview (Total Sales of 10 Power Companies)

- Electricity demand in the first half of fiscal 2008, measured in terms of the total electricity sales of the 10 power utilities, was up 0.2% on last year to 456.1 billion kWh.
- Outside the liberalized segment, lighting demand declined by 0.6% due principally to decreased demand for cooling caused by generally lower temperatures from mid August to September compared with last year.

Commercial demand in the liberalized segment declined by 0.1%.

Large industrial demand was up for the tenth consecutive term, increasing 2.7%.

The rise was due to year-on-year growth in all major sectors except textiles.
