Electricity Demand in January 2010 (Confirmed Report)

Demand Overview (Total Sales of 10 Power Companies)

- Electricity demand in January, measured in terms of the total electricity sales of the 10 power companies, was up 4.6% on last year to 81.4 billion kWh.
- Outside the liberalized segment, lighting demand rose by 3.9% year on year due principally to increased heating demand caused by relatively lower temperatures from mid December to mid January, compared with a year ago, in addition to a longer meter-reading period than the last year.

Commercial demand in the liberalized segment increased by 0.6%.

Large Industrial Demand (up 10.8% on the year, 21.57 billion kWh in total)

Large industrial user demand was up year on year for two consecutive months, increasing by 10.8%. This was due mainly to the year-on-year increase in major sectors including machinery, steel and chemicals.
