

Electricity Demand in June 2010 (Confirmed Report)

Demand Overview (Total Sales of 10 Power Companies)

- Electricity demand in June, measured in terms of the total electricity sales of the 10 power companies, was up 5.0% on last year to 67.6 billion kWh.

- Outside the liberalized segment, lighting demand rose by 2.4% year on year due principally to increased cooling demand caused by relatively higher temperatures from mid to late June, compared with a year ago.

Commercial demand in the liberalized segment decreased by 0.7%.

Lighting Demand (up 2.4% on the year, 18.57 billion kWh in total)

Large Industrial Demand (up 12.0% on the year, 24.15 billion kWh in total)

Large industrial user demand was up year on year for seven consecutive months, increasing by 12.0%.

This was due mainly to the year-on-year increase in all major sectors including steel.
