Electricity Demand in the Second Half of Fiscal 2010 (Bulletin)

Demand Overview (Total Sales of 10 Power Companies)

- Electricity demand in the second half of fiscal 2010, measured in terms of the total electricity sales of the 10 power utilities, was up for three consecutive half terms, increasing by 2.5% on last year to 448.2 billion kWh.
- Outside the liberalized segment, lighting demand rose by 3.7% due principally to increased demand for heating caused by generally lower temperatures this winter compared with a year ago.

Commercial demand in the liberalized segment declined by 0.1%.

Large industrial demand was up for three consecutive half terms, increasing by 3.2%. This was due mainly to year-on-year increase in all major sectors including steel.
