Demand Overview (Total Sales of 10 Power Companies)

- Electricity demand in the first half of fiscal 2013, measured in terms of the total electricity sales of the ten power companies, decreased by 1.0% from the last year to 418.2 billion kWh.
- Outside the liberalized segment, lighting demand declined by 1.0% due principally to decreased heating demands caused by relatively higher temperatures from March to early April than last year, in spite of increased cooling demands caused by relatively higher temperatures from June to August than last year.

Commercial demand in the liberalized segment dropped by 0.3% due mainly to decreased heating demands caused by relatively higher temperatures in early April than last year, in spite of increased cooling demands caused by relatively higher temperatures from June to August than last year.

Lighting Demand (down 1.0% on the year, 130.83 billion kWh in total) Commercial Demand (down 0.3% on the year, 97.41 billion kWh in total)

Large industrial demand was down for the fifth consecutive half term, decreasing by 1.2%. This was due mainly to year-on-year decrease in major sectors except for textiles.
