Electricity Generated and Purchased in the Second Half of Fiscal 2015 (Bulletin)

1. Nationwide Summary

Total electricity generated and purchased across the ten companies in the second half of fiscal 2015 declined by 4.3% from last year to 439.5 billion kWh, due mainly to decreased heating demands caused by relatively higher temperatures from December to March than last year.

Breakdown

Hydro

Hydroelectric generation increased by 2.3% from last year to 25.85 billion kWh, despite the lower flow rate due to an increase in capacity than last year.

Thermal

Thermal power generation declined by 7.3% from last year to 314.29 billion kWh, due mainly to the decline in the amount of electricity generated and purchased as a whole.

Nuclear

Nuclear power generation was 8.5 billion kWh, due to higher capacity factors than last year.

Capacity factors in the second half of fiscal 2015 and the second half of fiscal 2014 were 5.5% and 0.0%, respectively (Japan Atomic Power Company figures excluded).

Flow Rates

The flow rate across the nine companies except for Okinawa was 110.7%.
