

Electricity Demand in Second Half of Fiscal 2012(Bulletin)

Demand Overview (Total Sales of 10 Power Companies)

- Electricity demand in the second half of fiscal 2012, measured in terms of the total electricity sales of the 10 power companies, declined by 1.9% from last year to 429.3billion kWh.

- Outside the liberalized segment, lighting demand decreased by 0.4% due principally to the efforts of customers for saving electricity.

Commercial demand in the liberalized segment showed little change from the previous year, increasing by only 0.1%.

Large industrial demand was down for the fourth consecutive half term, decreasing by 4.7%.

This was due mainly to a year-on-year decrease in all major sectors.
